The Charlotte Historic District Commission will hold a public hearing Wednesday, May 14, at 12:30 p.m. on the proposed nomination of the Johnston Building to the National Register of Historic Places.

The project is scheduled for presentation to the North Carolina National Register Advisory Committee at its meeting on June 12. During this meeting, the committee will decide whether to recommend the nomination for submittal to the U.S. Department of the Interior, National Park Service, for final review and listing in the National Register.

The National Register is the nation's official list of historic buildings, districts, archaeological sites and other resources worthy of preservation. More than 3,000 North Carolina properties are now listed in the National Register. Listing in the National Register places no obligation or restriction on a private owner using private resources to maintain or alter the property.


